

# TERMS AND CONDITIONS FOR THE “GIFT FOR GRANDPARENTS” PROMOTIONAL CONTEST

## 1. GENERAL PROVISIONS

- 1.1. Contest - the promotional campaign under the „GIFT FOR GRANDPARENTS” name, run on the terms set out in this Regulations hereinafter referred to as the “Contest”.
- 1.2. Organizer - MASTERMEDIA CIOCZEK I WÓJCIAK SP.J..
- 1.3. Participant - an adult natural person residing in the Great Britain, having full legal capacity, who during the Contest performed a competition task published on the Fanpage of the Organizer in the form of a Contest Post.
- 1.4. Fanpage – the official Food Plus Great Britain Facebook page on Facebook: <https://www.facebook.com/foodplus.gb>
- 1.5. Contest Post – details of contest posted on Food Plus Great Britain Fanpage.
- 1.6. Contest Commission – a team of people supervising the proper conduct of the Contest and selecting the winners.

## 2. ORGANIZER OF THE ACTION

- 2.1. The Organizer of the Contest is MASTERMEDIA CIOCZEK I WÓJCIAK SP.J. is registered at Wojciechowska 9B, 20 - 704 Lublin, and entered into the register of entrepreneurs in Poland, under the VAT number PL7120155884.
- 2.2. The Contest will be held from 14th January 2020 (Tuesday, 8:00 AM GMT) till 16th January 2020 (Thursday, 3:00 PM GMT) on Organizer’s Facebook page. The results will be announced on January 17, 2020 till 5:00 PM GMT under the competition post.
- 2.3. The Contest is not organized with the participation of, nor sponsored or supported by the owner of the Website. Facebook is a registered trademark of Facebook Inc., its use for the purposes of this Contest takes place in accordance with the provisions of the Service Regulations. Facebook Inc. is not responsible for the proper course of the Contest. All claims related to Contest should be directed exclusively to the Organizer.
- 2.4. The Organizer warns that he is not responsible for any events that prevent the Contest from running correctly, which he was not able to predict or which he could not prevent in case of random events.
- 2.5. The Organizer is not responsible for the functioning of the Internet, through which the Participants send applications and proposals for answers to contest questions, as well as through which the Organizer contacts the Participant.

### **3. CONDITIONS FOR PARTICIPATION**

- 3.1. As part of the Contest, the Organizer places details of competition in a Contest Post on his Fanpage.
- 3.2. The participant submits the application by completing the task described in the Competition Post.
- 3.3. Contest application: responses can't violate the rights of third parties, as well as moral norms – in particular they can't contain or suggest content commonly considered vulgar or offensive, containing erotic, obscene, offensive feelings, including religious feelings, depictions of violence, racist content and material protected by exclusive or infringing rights to privacy
- 3.4. The Organizer will select six winners of the competition who have published the most interesting answer in the commentary below Contest Post. In the assessment of responses, the Organizer's own criteria (creativity, adequacy, ingenuity) will be taken into account. Winner can win only 1 (in words: one) Prize, regardless of the number of entries made.
- 3.5. Taking a part in the Contest, Participant declares:
  - 3.5.1. to have proprietary, property and personal rights to the content published in the application, including the right to send it to the Competition
  - 3.5.2. the content and materials contained in the competition application do not violate the rights of third parties.
- 3.6. The Participant have full responsibility towards the Organizer in the case of third parties making claims in relation to the Organizer for violation of their rights, as a result of the Organizer's use of the application sent by the Participant.
- 3.7. In the event of infringement of the copyrights by the Participant, the Organizer is authorized to provide personal data of the Participant to third parties. This data may be used by third parties to assert their rights in court for the infringement of their copyrights.
- 3.8. The Organizer, immediately after selecting the winners, will notify them via a comment under the competition post on Facebook.com and ask for contact in a private message to complete the contact details for the purpose of collecting the prize
- 3.9. The Contest will not include declarations that Facebook administrators will remove or permanently prevent access to them as a result of violation of the site rules.
- 3.10. The Contest's representatives, shareholders, employees, co-workers and their ascendants, descendants, siblings, spouses and persons connected with them for the adoption, custody or guardianship cannot participate in the Contest.

### **4. PRIZES**

- 4.1. The prizes in the Competition are six surprise gifts in the form of a bouquet of flowers or sweets (the Organizer decides about the choice), which will be sent via Flower Post to the persons indicated by the Winners. Each Winner is entitled to only one prize, which will be sent to the one address he indicates. The value of one gift is 250 PLN (in words: two hundred fifty zlotys).
- 4.2. The Winners are required to provide the first name, last name, full address and telephone number (optional) of the gifted person.

- 4.3. The above address details should be provided no later than 18/01/2020 by 10.00 AM GMT. Providing address details is necessary to send the prize. In the event of refusal to provide address details or failure to meet the deadline for providing them to the Organizer - the prize will be forfeited and on its further use, the Organizer of the Contest shall decide.
- 4.4. Prizes will be delivered to the indicated address no later than January 23, 2020.
- 4.5. It is not possible to pay the equivalent of the prize

## **5. PROCESSING OF PERSONAL DATA**

- 5.1. The Contest Organizer is the administrator of the personal data of the Contest Participants.
- 5.2. The Administrator referred to in paragraph 1, processes personal data in accordance with the Article 6 paragraph 1 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016.
- 5.3. The Personal data will be processed only for purposes related to the Contest, i.e. to select Winners of the contest, for purposes related to the competition and the awarding of prizes, (name, last name, e-mail address, telephone number).
- 5.4. Providing personal data is voluntary, but necessary to collect prizes and consideration of possible complaints. Persons providing personal data have the rights to: access to data, the possibility of correcting them, requesting the deletion of data and stop processing them.

## **6. FINAL PROVISIONS**

- 6.1. By participating in the contest, you automatically accept these Terms and Conditions. Participants are obliged to comply with these Regulations. Failure to comply with the Rules may result exclusion from participation in the competition.

- 6.5. The provisions of these Terms are subject to the provisions of Polish law. In matters not covered by the Terms, the provisions of the Civil Code, the Act on Copyright and Related Rights and other acts are applicable.
