

TERMS AND CONDITIONS FOR THE "FIND NAME FOR OUR HERO AND WIN!" PROMOTIONAL CONTEST

1. DEFINITIONS

1. "Contest" - the promotional campaign under the „FIND NAME FOR OUR HERO AND WIN!" name, run on the terms set out in this Regulations.
 2. "Organiser" - Mastermedia Cioczek i Wójciak Spółka Jawna with its registered office in Lublin, address: ul.Wojciechowska9B, 20-704 Lublin, Poland, entered into the Register of Businesses of the National Court Register (KRS) kept by the District Court in Lublin, XI Economic Division of the National Court Register under KRS No. 0000447072, NIP (Tax ID): 712-015-58-84.
 3. "Participant" - an adult natural person, having full legal capacity, who during the Contest performed a competition task published on the Fanpage of the Organizer in the form of a Contest Post.
 4. "Fanpage" - the official Food Plus Facebook Fanpage on Facebook: <https://www.facebook.com/foodplus.eu>
 5. "Contest Post" - details of contest posted on Food Plus Fanpage.
 6. "Contest Commission" - a team of people supervising the proper conduct of the Contest and selecting the winners.

7. "Laureate" – a Participant of the Contest indicated by the Contest Commission and awarded by the Organiser.

2. ORGANISER OF THE ACTION

1. The Contest will be held from 9th of September 2021 (Thursday, 8:00 AM GMT) till 30th of September 2021 (Thursday, 11:59 PM GMT) on Food Plus Fanpage. The results will be announced till 15th of October 2021 till 10:00 AM GMT under the Contest Post.
2. The Contest is not organised with the participation of, nor sponsored or supported by the owner of the Website. Facebook is a registered trademark of Facebook Inc., its use for the purposes of this Contest takes place in accordance with the provisions of the Service Regulations. Facebook Inc. is not responsible for the proper course of the Contest. All claims related to Contest should be directed exclusively to the Organiser.
3. The Organiser warns that he is not responsible for any events that prevent the Contest from running correctly, which he was not able to predict or which he could not prevent in case of random events.

4. The Organiser is not responsible for the functioning of the Internet, through which the Participants send applications and proposals for answers to contest questions, as well as through which the Organiser contacts the Participant.

3. CONDITIONS FOR PARTICIPATION

1. As part of the Contest, the Organiser places details of competition in a Contest Post on his Fanpage.

2. A competition task is to propose a name for the Hero of the Food Plus chain.

3. The participant submits the application by completing the task described in the Contest Post.

4. Contest applications can't violate the rights of third parties, as well as moral norms - in particular they can't contain or suggest content commonly considered vulgar or offensive, containing erotic, obscene, offensive feelings, including religious feelings, depictions of violence, racist content and material protected by exclusive or infringing rights to privacy.

5. The Contest Commission will select 1 Laureate of the competition who has published the most interesting answer in the commentary below the Contest Post. In the assessment of responses, the Organiser's own criteria (creativity, adequacy, ingenuity) will be taken into account.

6. Taking part in the Contest, Participant declares:

6.1. to have proprietary, property and personal rights to the content published in the application, including the right to send it to the Contest,

6.2. the content and materials contained in the contest application do not violate the rights of third parties.

7. The Participant have full responsibility towards the Organiser in the case of third parties making claims in relation to the Organiser for violation of their rights, as a result of the Organiser's use of the application sent by the Participant.

8. In the event of infringement of the copyrights by the Participant, the Organiser is authorized to provide personal data of the Participant to third parties. This data may be used by third parties to assert their rights in court for the infringement of their copyrights.

9. The Organiser, within maximum two weeks after selecting the Laureate, will notify them via a comment under the Competition post on Food Plus Facebook page and ask for contact in a private message to complete the contact details for the purpose of collecting the prize.

10. The Contest will not include declarations that Facebook administrators will remove or permanently prevent access to them as a result of violation of the site rules.

11. The Contest's representatives, shareholders, employees, co-workers and their ascendants, descendants, siblings, spouses and persons connected with them for the adoption, custody or guardianship can participate in the Contest.

4. PRIZES

1. The prize in the Contest is a set consisting of the Titanum 4W Trolley Black Shark suitcase and JBL FLIP 4 wireless loudspeaker.
2. The Laureate is required to provide their personal data necessary to issue a prize, i.e.: name, surname, telephone number and address.
3. The prize will be send to the address indicated by the Laureate till 31.10.2021.
4. It is not possible to transfer the right to the prize to the third parties. It is not possible to pay the equivalent of the prize. In the event of the winner's resignation from the prize on its further use, the Organiser of the Contest shall decide.
5. Each Participant can only win one prize, regardless of the number of entries made.

5. PROCESSING OF PERSONAL DATA

1. The Contest Organiser is the administrator of the personal data of the Contest Participants.
2. The Administrator referred to in paragraph 1, processes personal data in accordance with the Article 6 paragraph 1 of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016.
3. The Personal data will be processed only for purposes related to the Contest, i.e. to select the Laureate of the contest, for purposes related to the Contest and the awarding of prize, (name, surname, e-mail address, telephone number and address).
4. Providing personal data is voluntary, but necessary to collect prizes and consideration of possible complaints. Persons providing personal data have the rights to: access to data, the possibility of correcting them, requesting the deletion of data and stop processing them.

6. FINAL PROVISIONS

1. By participating in the contest the Participant automatically accepts these Terms and Conditions. Participants are obliged to comply with these Regulations. Failure to comply with the Rules may result exclusion from participation in the Contest.
